# **MO Tariffs & Charges and Imperfections Charge**

**01 October 2024 - 30 September 2025**

**02 September 2024**

## Introduction

The tariffs and charges published by SEMO in this paper are applicable for the period 01 October 2024 to 30 September 2025 as approved by the Regulatory Authorities (RAs). These tariffs will be applied in accordance with the Trading and Settlement Code – Part B (the T&SC), as may be amended from time to time with the approval of the RAs.

On 23 August 2024 the RAs published an information paper ([SEM-24-058](#)) confirming the Market Operator Revenues. On the same date a letter was issued by the RAs to SEMO on the same date confirming the market operator tariffs<sup>1</sup>.

On 23 August 2024, the RAs confirmed in a letter the SEM tariffs and charges<sup>2</sup> to apply from 01 October 2024 – 30 September 2025.

On 02 September 2024 the RAs confirmed by correspondence the Imperfections Charge and the Imperfections Charge Factor to be applied from 01 October 2024 (noting that a formal paper would also be published capturing same).

The AOLR charge, applicable to those utilising the AOLR services, is as approved as part of SEMO Price Control Decision [SEM-21-073](#).
