1 SECRETARIAT UPDATE

The Secretariat welcomed all to Capacity Market Workshop 26. It was advised that there were 3 proposals on the baseline and a Code Update has commenced.

2 TSO UPDATE

TSOs advised that CMC_11_21 is still on track for timelines given previously and an implementation was still on course for Quarter 2 2023. TSOs advised that a requested Market Systems Development Update for each Workshop was under consideration.

3 **NEW MODIFICATIONS**

3.1 CMC_10_22

EPEDL presented the Modification Proposal.

The Proposer gave a <u>presentation</u> noting that this proposal will extend the long-stop date and the maximum duration of New Capacity in instances where Substantial Completion has been delayed as a result of the delivery of third-party activities in a timely manner. The proposal will be treated as 'standard' as, according to the RAs, the proposal did not qualify as 'urgent'.

Modification Status - RA Consultation

4 AOB

Tynagh presented slides on Trading and Settlement Code Mod 07 22 Indexation to Calculation of Capacity Payments for New Capacity. This Modification was raised at Modifications Committee Meeting 111 where it was noted that there were areas of overlap with the Balancing and Capacity Market. The Modification Proposal was discussed further, and it will be progressed at the next Modifications Committee Meeting in September.

Secretariat thanked all for attending Capacity Market Workshop 26 and noted that Capacity Workshop 27 will take place on Thursday, 22nd September 2022.
