Introduction

The tariffs and charges published by SEMO in this paper are applicable for the period 01 October 2020 to 30 September 2021 as approved by the Regulatory Authorities (RAs). These tariffs will be applied in accordance with the Trading and Settlement Code – Part B (the T&SC), as may be amended from time to time with the approval of the RAs.

On the 13 February 2018 the SEMC published SEMO Price Control ([SEM-18-003](#)). The AOLR charge, applicable to those utilising the AOLR services, was approved as part of this decision (Ref. Section 8.1)

On 18 August 2020 the RAs published a decision paper ([SEM-20-057](#)) approving the Supplier Capacity Charge Price, the Difference Payment Socialisation Multiplier, the Residual Error Volume Price, the Currency Adjustment Charge and the Annual Capacity Charge Exchange Rate required under the T&SC for the operation of the Single Electricity Market.

On 10 August 2020 the RAs published a decision paper ([SEM-20-051](#)) approving the Market Operator Revenues for 2020/21. The Market Operator tariffs were subsequently approved by the RAs via letter on 21 August 2020¹.

On 27 August 2020 the RAs published a decision paper detailing the Imperfections Price and the Imperfections Charge Factor to be applied from 01 October 2020 ([SEM-20-058](#)).
