

The following release activity is included in Market System Release Capital and Market System Release Support

- Release costs FY24 relate to Release M which was deployed July 2024
- Release M had a Greenlink and Non Greenlink element. Non Greenlink is the additions in 2024. Greenlink element is in AUC at Sept 24 as Greenlink itself has not gone live
- Release AUC Sept 24 is Release M (Greenlink) €849k
- TSO related Release M costs were transferred to the TSO's in FY 24 of which €162k was Non Greenlink and €1,578k for Greenlink which is AUC in the TSO's

Predictable Capex

- SEM Infrastructure Refresh are an ongoing cost with regular refreshes taking place each year
- SEM Finance System: This project has commenced in FY24 and is a cloud opex cost
- SEM Finance System was allowed for in the Predictable Allowance but as it is a Cloud Project it is noted in the cloud costs.
- Website development: Due to go live in FY25
- Automated Test Capability: Work completed in FY24

Unpredictable Capex


- Enduring Data hub phase 2 went live in FY24.
- AUC for Greenlink and SDP in Unpredictable heading relates to costs of these projects in SEMO

The figures shown for the Market System Releases and Market Systems Release Support are the release costs for SEMO. These numbers are provisional and subject to audit.


The total FY23/24 Assets under construction includes any project that was not complete as of 30th September 2024.




Volumd Trade vs Avg. price (DA)



- Volumes within the DAM have remained consistent with previous years, following a seasonal trend, with a 2% increase in November volumes compared to previous years.
- After August, there is an upward trend in DAM prices, with November being 46% higher than August 2024 and 19% lower than the same month last year.
- November 2024 past the price record on 2022 being the highest November since then.




- The year-to-date average for 2024 has been 14% less than in 2023.
- November 2024 has seen high volatility in the SEM where the highest price was 21% higher than the highest price in Nov. 2023 and the lowest price was 58% lower than the same in Nov. 2024.



- November show a 18% increase in electricity prices, in line with the 10% increase in gas prices.
- Wind power generation decrease by 14%, compered to October. But the highest wind generation was registered on the 28th of November, showing the second lowest avg price on 2024

Volumd Trade vs Avg. price (IDA's)



- Volumes within IDA1 continue to be influenced by the interconnector.
- After a continuous increase in volumes in IDA1, a 5% drop was seen in November, possibly aligned with an increase in closed volumes in the DAM.
- IDA2 and IDA3 have maintained a constant behavior with no significant changes.

Other Updates

BidAsk Curve File - Change in Number of Decimals

- Current state:
 - Prices rounded to 2 decimal places
 - Volumes rounded to 1 decimal place
- Future state:
 - Prices unrounded up to 13 decimal places
 - Volumes unrounded up to 13 decimal places
- Rationale for change:
 - Round values creates "false horizontal segments" in the aggregated curves and gives the appearance of equal prices or volumes where discrepancies actually exist
 - Example: €15.123 ≠ €15.124, but both rounded to €15.12
 - Concerns raised by members regarding the discrepancies causing complications when validating aggregated curve data
- Sample Files will be available by end of Dec 2024
- Target go-live of change is February 2025
