Settlements: Other updates...

- FMOC Invoice published on Nov 15th included the incorrect CMOAU and CMOAV rates for ROI and NI market participants: <u>Market message</u> published on the 18/11/2022.
 - As per updates provided on the weekly market participant calls, SEMO Settlements are intending to publish an Oct 2022 MO Invoice which will reverse the original invoice issued, and to then re-publish the correct Oct 2022 MO invoice with the correct rates.
 - This invoice correction will be scheduled to take place in the New Year, with a date to be confirmed with market participants once the scenario has been fully replicated and tested in the systems test environment.
