2 Introduction

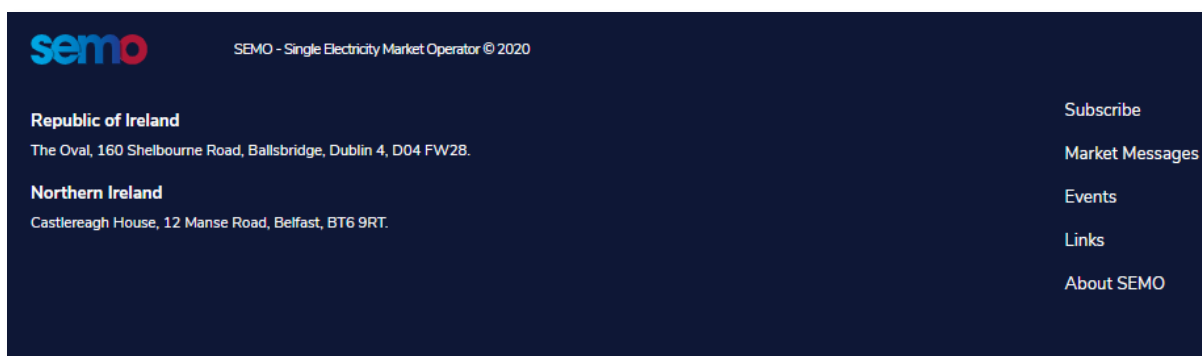
This document describes the process to register for the market messages issued by SEMO via the public website.

This section describes how the general public can sign up to avail of the SEMO Market Messages via the SEMO website.

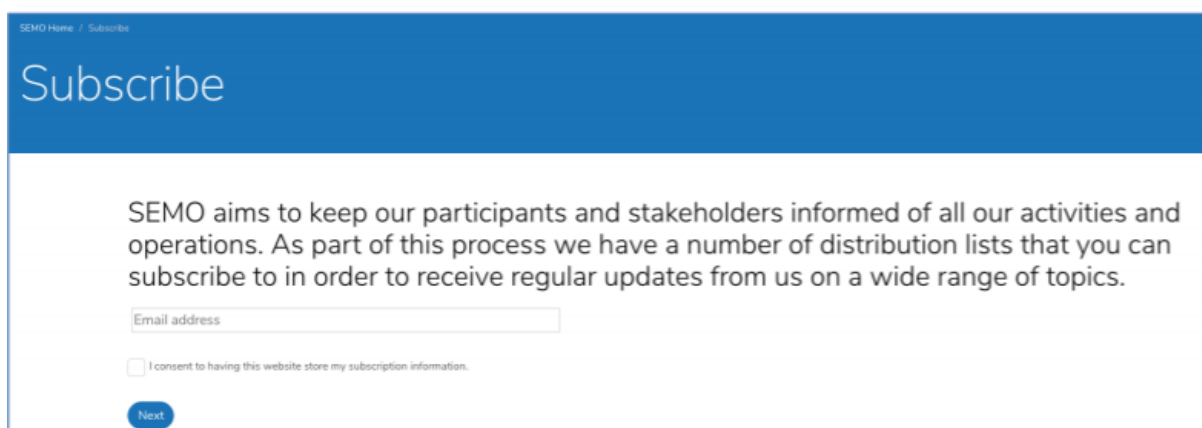
3.1 Navigate to the Subscription Page

The first step is to navigate to the subscription page. The link to this is called Subscribe, and is found in the footer at the bottom of every web page on the SEMO website.




3.2 Provide Your Email Address

Once you're on the Subscribe page, the first screen has a box which will prompt you to enter your email address. In this box, type the email address where you want to receive market messages.



Once you have entered your email address, you must click to tick the box beside "I consent to having this website store my subscription information." This is required to allow our system to remember your email address so we can send you the market messages.




