# SEM R2.7.0 – October 2015

- SEM R2.7.0 was successfully deployed on October 2<sup>nd</sup> 2015
- Approved release scope was as follows:

# REMIT Update

- Registration with ACER on the ARIS system is complete.
- Files are being submitted to ACER as of October 7<sup>th</sup> as per the REMIT reporting timeline.
- Validation messages are being returned on some file content. This is expected for a programme of this scale - ACER have contingencies in place to deal with this.
- Other RRM's throughout Europe are experiencing similar issues.
- SEMO are working with ACER to remedy this issue however all data is being submitted to ACER as required under REMIT.
