APPROVED MODIFICATION TO CAPACITY MARKET CODE DRAFTING

Modify:

E.4.1.2 Subject to paragraphs E.4.1.3 and E.4.1.3A, an Application for Qualification shall contain the Qualification Data and be submitted in the format specified by the System Operators.

Add:

E.4.1.3A A Participant required to make an Application for Qualification in respect of a Candidate Unit that has previously Qualified in respect of the same Capacity Year may choose to opt-in to the Alternative Qualification Process provided that:

- (a) the Candidate Unit comprises the same group of Generator Units as the previously Qualified CMU;
- (b) the Initial Capacity (Existing) is the same as the previously Qualified CMU; and
- (c) the Initial Capacity (Total) is equal to the Initial Capacity (Existing).

Modify:

E.4.1.4 Unless a valid Opt-out Notification is received by the System Operators or the Participant has opted-in to the Alternative Qualification Process, a Participant must ensure that Qualification Data is complete and current in respect of each of its Candidate Units which it is seeking to be Qualified as at the Qualification Application Date specified in the Capacity Auction Timetable.

Modify:

E.7.8.1 Where:

- (a) a Participant is required to apply for a Candidate Unit to be Qualified to participate in a Capacity Auction under section E.2;
- (b) either a Participant has opted-in to the Alternative Qualification Process in respect of a Candidate Unit under paragraphs E.3.1.4A;
- (c) or
 - (i) the Participant has not submitted an Opt-out Notification in relation to the Candidate Unit for the relevant Capacity Year, or has submitted an Opt-out Notification in relation to the Candidate Unit and it has been rejected under paragraph E.3.1.4; and
 - (ii) the Participant either fails to submit an Application for Qualification in relation to the Candidate Unit for the relevant Capacity Year or its Application for Qualification is rejected due to deficient or incorrect information; and
 - (iii) the System Operators are not aware of any reason why the Candidate Unit should not be Qualified.

- ~~(b) the Participant has not submitted an Opt-out Notification in relation to the Candidate Unit for the relevant Capacity Year, or has submitted an Opt-out Notification in relation to the Candidate Unit and it has been rejected under paragraph E.3.1.4;~~
- ~~(c) the Participant either fails to submit an Application for Qualification in relation to the Candidate Unit for the relevant Capacity Year or its Application for Qualification is rejected due to deficient or incorrect information; and~~
- ~~(d) the System Operators are not aware of any reason why the Candidate Unit should not be Qualified;~~

the System Operators shall determine Qualification Decisions for that Candidate Unit in accordance with paragraph E.7.8.2.
