**B.8.1.3** A Participant shall notify the Market Operator of any change with respect to the SEM NEMO(s) through which it intends to participate in a day-ahead or intraday market in respect of a Unit prior to the change taking effect.

**B.8.1.4** Where:

- (d) a SEM NEMO delegates to any person (“**Delegate**”) any of its tasks under the EU Guideline on Capacity Allocation and Congestion Management; and
- (e) one or more of the SEM NEMO’s obligations under paragraphs B.8.1.2(c) to (f) relates to the task which has been delegated (“**Related Obligation**”),

then:

- (i) the SEM NEMO shall procure that the Delegate accedes to the Framework Agreement and thereby becomes a Party to this Code;
- (ii) the Delegate shall perform the Related Obligation; and
- (iii) the SEM NEMO is relieved of the Related Obligation to the extent that the Delegate performs it.
